



DECEMBER 15, 1980

The Board of County Commission met this day in special session with the following members present, to-wit: Clayton Shiver, Chairman, Bobby Varnum, Donnell Whitfield and Monroe Cox.

Willie D. Wise, Clerk, Sheriff William G. Smith and Attorney Bill Corbin were present and acting.

The meeting was called to order by Chairman Shiver.

This meeting is a public hearing to adopt the final budget.

Chairman Shiver stated that the millage rate was 6.876 to bring in \$672,067.00 for the Fiscal Year 1980-81. (FOR RESOLUTION, SEE SUPPLEMENTAL MINUTE BOOK 1, PAGE 170, SECTION C)


Approximately 35 citizens were present for the hearings.

It was requested from the audience that a citizens committee get with the property appraiser on an equal assessment of all the property in the county.

A motion was made by Commissioner Cox, seconded by Commissioner Whitfield and duly carried to adopt the budget in the amount of \$1,711,105.00 by resolution. (FOR RESOLUTION, SEE SUPPLEMENTAL MINUTE BOOK 1, PAGE 169, SECTION C)
