The meeting was called to order by Chairman Shiver.


The purpose of the meeting was to approve the resolution on Rysco.

MINUTES OF JUNE 16, 1981

The Board of County Commission met this day in regular session with the following members present, to-wit: Clayton Shiver, Chairman, Bobby Varnum, Donnell Whitfield, Jack Bowman and Monroe Cox.

Deputy Clerk Gail O'Bryan, Sheriff William G. Smith and County Attorney Bill Corbin were present and acting. The meeting was called to order by the Sheriff followed with prayer by Commissioner Bowman.

Mr. Jim Yelvington met with the Board regarding his annual and sick leave time he has accumulated due to the fact he is retiring. The Board agreed to pay Mr. Yelvington for his sick and annual leave according to the Board of County Commission's personnel policy.

C. J. Roberts asked about Jim Taylor's annual leave. The Board advised that Mr. Taylor would be paid for his annual leave according to the Board of County Commission's personnel policy.

Ms. Neel with the Library Board made a report to the Board.

Commissioner Cox made a report on repairs for the Pan. Parts, labor, etc. for the Pan will be approximately \$3,250.00.

A motion was made by Commissioner Varnum, seconded by Commissioner Whitfield and duly carried to give Earl O'Bryan temporary aid in the amount of \$48.30.

Commissioner Shiver presented a statement to the Board from Share Corporation for \$1,329.00 for road hardening materials. The Board decided for the Clerk to write a letter and advise Share Corporation that the condition of paying for the material was if it worked, and, it did not..


Chairman Shiver went on record as being opposed to the game wardens patrolling Southwest Forest Industries' property and making cases against people trespassing on their lands.

BOARD OF COUNTY COMMISSION
MINUTES OF JULY 7, 1981

The Board of County Commission met this day in regular session with the following members present, to-wit: Bobby Varnum, Vice-chairman, Donnell Whitfield, Jack Bowman and Monroe Cox. Commissioner Shiver was absent due to being in the hospital.

Clerk Willie D. Wise, Sheriff William G. Smith and Bill Corbin, County Attorney, were present and acting. The meeting was called to order by the Sheriff followed with prayer by Commissioner Cox.

Bids were advertised for paving the Wrennie Moody Road. Commissioner Cox stated the road was not ready, and that it would be another 28 days.

A motion was made by Commissioner Whitfield, seconded by Commissioner Cox and duly carried to reject all bids and readvertise when the road bed was ready.

Ms. Neel with the Calhoun County Library stated that the parking area was being used by other businesses. Commissioner Cox suggested putting a sign up stating that the lot was for library parking only. A motion was made by Commissioner Bowman, seconded by Commissioner Cox and duly carried to place a parking sign at the Library.

Mr. Lampcain asked about the garbage pickup. Commissioner Varnum stated the Commission was still in the process of checking out all details.
