The purpose of the meeting was to close out the Fiscal Year 1980-81.



SEPTEMBER 30, 1981

The Board of County Commission met this day for the purpose of a public hearing with the following members present, to-wit: Clayton Shiver, Chairman, Bobby Varnum, Jack Bowman and Donnell Whitfield. Commissioner Cox was absent due to illness.

Willie D. Wise, Clerk, and Sheriff William G. Smith were present and acting.

The meeting was called to order by Commissioner Shiver and was followed with prayer by Commissioner Bowman.


The purpose of the meeting was to review the proposed budget for the Fiscal Year 1981-82.

Clerk Willie D. Wise presented the proposed budget to an audience of approximately 50 citizens by explaining each fund and line item of the proposed budget.


A motion was made by Commissioner Whitfield, seconded by Commissioner Bowman and duly carried to adopt a resolution to tentatively set the millage at 10 mills with an increase of 25.7% (7.53 - General; .38 - transportation and 1.99 - fine and forfeiture).
