BOARD OF COUNTY COMMISSION
 MINUTES OF NOVEMBER 1, 1983

The Board of County Commission met this day in regular session with the following members present, to-wit: Jack Bowman, Chairman, Drew Peacock, Monroe Cox, Roy Bailey and Donnell Whitfield.

Clerk Willie D. Wise, Sheriff William G. Smith and Attorney David House were present and acting.

The meeting was called to order by Sheriff Smith followed with prayer by Commissioner Cox.

The minutes of the meeting held October 18, 1983, were read and approved.

After some discussion of the old courthouse, it was decided the courthouse is to be covered by county general liability.

Mr. Gene McClellan, HUD Director, made a report on the HUD Program.

Mr. Alvin Roberts reported that he had received quotes on the capret for the FHA office which are as follows:

Flanders'	-----	\$ 460.78
Bowden's	-----	458.66
Furniture House	-----	799.00 (18 oz) and \$949.00(24 oz)

A motion was made by Commissioner Whitfield, seconded by Commissioner Peacock and duly carried to accept the bid of \$458.66 from Bowden's.

Mrs. Vonnie Duke, Tax Collector, met with the Board to get approval for refunding tax that had been paid twice. After discussion, the Board agreed for the Tax Collector to get approval from the Department of Revenue.

November 1, 1983 - continued

Mr. Dan Yoder, County Health Officer, met with the Board to see if the Health Department could charge a \$10.00 fee for physical exams for children entering child care centers. After some discussion, a motion was made by Commissioner Whitfield, seconded by Commissioner Bailey and duly carried for the Health Department to perform state mandated physicals for day care centers at a rate of \$10.00.

A motion was made by Commissioner Peacock, seconded by Commissioner Whitfield and duly carried that since money is available, to pave the loop at Calhoun General Hospital, Hwy. 73-A and Hwy. 274.

Sheriff William G. Smith stated a 25 MPH speed limit sign needed to be posted on the road from Hwy. 69 to the hospital, known as Finley Avenue. The Board agreed.


Ms. Brenda Gatlin with CAP met with the Board and stated the out line stations were closed for distributing the cheese, butter, etc.
