

BOARD OF COUNTY COMMISSIONERS
MINUTES OF OCTOBER 16, 1984

The Board of County Commissioners met this date in regular session with the following members present to wit: Chairman Drew Peacock, Commissioner Roy Bailey and Monroe Cox.

Deputy Clerk Gail O'Bryan, Attorney David House and Sheriff Willia G. "Buddy" Smith were present and acting.

The meeting was called to order by Chairman Peacock and followed with prayer by Commissioner Cox.

The minutes of October 3 and October 4, 1984 were read and approved.

Chairman Peacock stated 1 bid has been received for re-surfacing as advertised, and was submitted by Gulf Asphalt Corporation. The bid is as follows:

1. The material, labor and equipment to install one inch thick Type II Asphaltic concrete overlay for the following width of pavements:
 - a. 14 feet wide @ \$7.67 per linear foot
 - b. 16 feet wide @ \$5.68 per linear foot
 - c. 18 feet wide @ \$6.39 per linear foot
 - d. 20 feet wide @ \$7.12 per linear foot
2. The material, labor and equipment to install sand-asphalt leveling material 500 pound stability (Marshall Method) for the unit price of \$49.30 per ton.

A motion by Commissioner Bailey and seconded by Commissioner Cox, and duly carried, to reject the bid for re-surfacing and re-bid at a later date.

Chairman Peacock stated there had been an error in publication of the weatherization advertizement for carpenter's helper by the County Record, and the applications received today would have to be held until the next Board meeting on November 7, 1984 in order to re-advertize the position for 2 more weeks.

Road Supt., Fernwood Bailey made a report on the road department.

Annie Bradwell, of the Farmers Home Administration, requested 3 heaters and 2 fans from the Board for her offices.

A motion was made by Commissioner Bailey, seconded by Commissioner Cox, and duly carried to purchase 3 heaters and 1 fan for the Farmers Home Administration and for them to be paid for from the Courthouse Fund.

Mr. Neal Mayo presented the Board a letter from Congressman Don Fuqua requesting the new Clarksville Post Office.

A motion was made by Commissioner Bailey and seconded by Commissioner Cox and duly carried to settle the Brooks case out of court for the sum of \$2902.00.

Attorney David House stated Grant Gentry, the City Manager, had requested the county let the city start dumping in the county dump due to D.E.R problems with their dump.

Commissioner Bailey recommended that the Board not work any more inmates until the County Attorney researches the matter, due to liabilities.



A motion was made by Commissioner Cox and seconded by Commissioner Bailey and duly carried to accept lease agreement with Big Bend Business Machines and County Probation Department.
