

Chairman Hires explained to the road department employees that pay raises had not been given this year due to loss of revenue for Fiscal Year 1985-86.

The Board expressed their gratitude for the good job the employees were doing and for the cooperation they had given to the Board of County Commissioners in making the road department a better department.

The Board and the Road Department Employees discussed methods to improve rough road conditions, procedures for grading roads, preventative maintenance, and the moral of the road department employees.

After much discussion on unsafe equipment, the Board agreed they did not want to institute or promote insubordination by the employees, but they did not want any employee jeopardizing his life or placing the county liable for a law suit by using unsafe equipment.

Commissioner Wood presented and explained a new form called Calhoun County Maintenance Work Order to be used in the future by the road department employees and/or any other department.

Chairman Hires discussed sick and comprehensive time. He stated sick time was a privilege earned and could only be used for actual illness.

The Board and Road Department Employees agreed that the workshop had been helpful and felt a better understanding had developed between the Board and the Road Department Employees.

BOARD OF COUNTY COMMISSIONERS
MINUTES OF MEETING

NOVEMBER 5, 1985

The Board of County Commissioners met this date in regular session with the following members present to wit: Chairman Emmanuel Hires, Commissioners Ronald Wood, Drew Peacock, Roy Bailey, and Charles Richards.

Clerk, Willie D. Wise, Deputy Clerk, Gail O'Bryan, Attorney David House, and Sheriff Smith were present and acting.

The meeting was called to order by Sheriff Smith and followed with a prayer by Commissioner Peacock, and pledge of allegiance to the flag.

The minutes of October 15, and October 17, 1985 were read.

A motion was made by Commissioner Richards, seconded by Commissioner Bailey, and duly carried to accept the minutes of October 15, and October 17, 1985, as read.

Attorney David House presented a Notice of Intent to consider the adoption of a county ordinance concerning the closing of the Kinard Community Center, from 7:00 pm to 9:00 a.m, prohibiting the use of alcoholic beverages at the Center, providing sanctions and penalties, and providing severability clause .

A motion was made by Commissioner Bailey, seconded by Commissioner Richards, and duly carried to advertise the Notice of Intent to adopt Ordinance #85-03.

Ms. Vanita Anderson, with Senior Citizens Association, and Mr. Bobby Grice, with the Department of Transportation, met with the Board to discuss a transportation grant and to ask the County Commission to advance between \$16,000 and \$20,000. for funding of the program until the grant money starts coming in.

Chairman Hires recommended that the Transportation Grant be tabled until the Clerk and the Board could meet and see if funding could be found.

A motion was made by Commissioner Peacock, seconded by Commissioner Richards, and duly carried to renew the lease with Senior Citizens on the County Building.

Mrs. Lynn Strawn, met with the Board to ask the Board for financial help in sending the Blountstown F. F. A. Team to the National Convention in Kansas City.

Chairman Hires stated after polling the Board, the Board would be unable to give the money requested for the Blountstown F.F.A. trip, however, the Board Members have agreed to individually donate funds to help the F.F.A. Boys, with personal funds.

Chairman Hires presented a monitoring report on the weatherization grant. The report complimented the quality of workmanship on the dwellings and the detail in the filing systems were both commended. The weatherization crew consists of Mrs. Fernwood Bailey, Don O'Bryan and Bobby Varnum.

Mr. Bud Clark, with Clark Roumoulis and Associates, presented an ordinance, re: The Fair Housing Act. Attorney David House read the Ordinance to the Board of County Commissioners and recommended the Board review same.

A motion was made by Commissioner Bailey, seconded by Commissioner Wood, and duly carried to advertise for bid for equipment, labor and insurance for the repairs on the Kinard Community Center, as per specifications promogated by Alvin Roberts, to be done by a licensed contactor, subject to a long term lease from the School Board.

Mr. George Koeber, met with the Board to request abandonment of the County Road in front of his property, off 274, West.

Commissioner Wood stated he had no objection to that portion of the road being closed, if all the property owners adjacent to the road agree to the closing with notorized statements.

Mr. Nathan Goodman, Civil Defense and Parks Recreation Director, made a report to the Board on his future plans for the S. B. Atkins Park, and recreational activities.

The Board agreed to begin locking the gate at S. B. Atkins Park at night, but to install a walk thru gate.

Chairman Hires presented the bid received from J. Hoyt Rackly for the erection of the steel building for the County Road Department in the amount of \$11,890.00.

A motion was made by Commissioner Richards, seconded by Commissioner Peacock, and duly carried to accept the bid from J. Hoyt Rackley in the amount of \$11,890.00, for the erection of the metal building.

Commissioner Richards stated he had moved his grader man to the road department due to the fact the budget is tight, and from this point on a grader man will be shared with Chairman Hires.

A motion was made by Commissioner Bailey, seconded by Commissioner Wood, and duly carried to file an Intent to Abandon the following described road, located in the boundaries of Calhoun County, and described as follows:

Clerk, Willie D. Wise presented from the Department of Army, Core of Engineers, approval of permit for work done on Crooked Creek.

Clerk Wise also presented the Board with a \$6,121.59 refund check from his 1984-85 budget.


There being no further business to come before this Board, they did then adjourn.

A motion was made by Commissioner Richards, seconded by Commissioner Peacock and duly carried to adopt the Citizens Participation Committee Resolution.


