THE BOARD OF COUNTY COMMISSIONERS MET THIS DATE IN SPECIAL SESSION.

THE BOARD MET THIS DATE IN SPECIAL SESSION TO DISCUSS AND REVIEW ROAD AND BRIDGE BUDGET--DOCKET AND RESURFACING.

AFTER DISCUSSION, THE BOARD UNANIMOUSLY AGREED FOR A 2 YEAR RESURFACING PROGRAM FOR THE FOLLOWING ROADS TO BE RESURFACED IN THIS PRIORITY.

1. 7 4/10'S OF HUGH CREEK, CLARK ROAD AND RIVER STREET OUTSIDE CITY LIMITS.
2. 3 7/10 MILES ON WEST HIGHWAY 392
3. J. P. PEACOCK 2.0
4. HIGHWAY 274 WEST 5 5/10 MILES
5. HIGHWAY 274--ALTHA TO SHELTON'S 5 MILES
6. HIGHWAY 275 NORTH--2 3/10 MILES
7. ROY GOLDEN AND WEST END 2 6/10 MILES OR LESS
8. 1 5/10 MILES WHITE POND ROAD TO INTERSECTION HIGHWAY 73

THE BOARD DECIDED AT THE END OF 2 YEAR PERIOD TO REVIEW AND ADOPT A NEW RESURFACING PROGRAM.

THE BOARD UNANIMOUSLY VOTED FOR EACH COMMISSIONER FOR THIS FISCAL YEAR (91) TO PAVE ONE MILE OF NEW CONSTRUCTION IN HIS DISTRICT. HE WOULD USE ROAD CREW AND HIS OWN ROAD AND BRIDGGE TIME TO PREPARE THE ROAD FOR COMPLETION WITH THE EXCEPTION OF LETTING A CONTRACT FOR THE ASPHALT PORTION.

ROAD SPECIFICATION FOR NEW CONSTRUCTION:

10 PM 1990

18 FT. WIDE

1 1/2 INCH THICK ASPHALT WITH PROPER BASE.

THE BOARD AGREED FOR PAVEMENT OF NEW CONSTRUCTION BY THE BOARD NOT CHARGABLE TO ANY DISTRICT TO PAVE MAGNOLIA CHURCH ROAD FROM HIGHWAY 71 TO THE ENTRANCE TO THE RECYCLING CENTER.

THE BOARD VOTED FOR ANY MONIES LEFT TO BE USED IN COMMISSIONER COX'S DISTRICT 5-0 AT THE END OF THE TWO YEAR PERIOD.

THE BOARD PARTIALLY REVIEWED CALHOUN COUNTY REGULATIONS AND DECIDED TO HOLD A SPECIAL BOARD MEETING ON THE 2ND THURSDAY IN JANUARY (JAN. 10TH) TO REVIEW REGULATIONS.

THE BOARD VOTED 5-0 FOR COUNTY EMPLOYEES TO BE OFF DECEMBER 24TH AND 25TH FOR CHRISTMAS VACATION.

THERE BEING NO FURTHER BUSINESS, THE BOARD DID ADJOURN.
