COUNTY ATTORNEY CORBIN PRESENTED TO THE BOARD A COPY OF THE "CHARGE AGAINST EMPLOYER" RE: INTERNATIONAL UNION OF OPERATING ENGINEERS, AFL-CIO, LOCAL UNION NO. 5 v. CALHOUN COUNTY BOARD OF COUNTY COMMISSIONERS. (SEE ATTACHED STATE OF FLORIDA PUBLIC EMPLOYEES RELATIONS COMMISSION CHARGES AGAINST EMPLOYER.)

GERALD FRYE AND SEVERAL CITIZENS WERE PRESENT TO DISCUSS THE COUNTY TAKING OVER CHIPOLA ROAD PAST BURDELL BAILEY'S HOUSE. MR. FRYE RELAYED THERE IS A SEVERE DRAINAGE PROBLEM DUE TO BEAVER DAMS.

COMMISSIONER WHITFIELD EXPLAINED THAT MR. FRYE HAD MET WITH THE BOARD PREVIOUSLY REGARDING THE ROAD AND THE BOARD HAD ADVISED HIM HE MUST GO BEFORE THE PLANNING COMMISSION AND ALSO BE IN COMPLIANCE WITH DER, DNR, AND ALL OTHER RELATED STATE AGENCIES. COMMISSIONER WHITFIELD SAID THE ROAD MUST MEET ALL COUNTY ROAD SPECIFICATIONS. HE RELAYED THE COUNTY MUST ALSO HAVE WORK EASEMENTS FOR THE ROAD.

MR. FRYE RELAYED THAT THE BOARD ALREADY HAS DRAINAGE EASEMENT AND REQUESTED THAT THE BOARD CLEAR OUT THE BEAVER DAMS FOR DRAINAGE PURPOSES. COMMISSIONER LINDSEY STATED HE WOULD MEET WITH MR. FRYE TO ASSESS THE PROBLEM AND IF THE COUNTY DOES HAVE DRAINAGE EASEMENTS WOULD SEE WHAT THE COUNTY COULD WORK OUT ON THE DRAINAGE PROBLEM.

THE CLERK PRESENTED THE ONLY BID RECEIVED, AS ADVERTISED, FOR PREPARING 1991-92 RECYCLING GRANT APPLICATION. THE BID RECEIVED WAS FROM TIA SOLID WASTE CONSULTANTS AND WAS FOR \$2800.00.

AFTER REVIEW AND DISCUSSION, MOTION BY COMMISSIONER GRANT TO ACCEPT THE BID FROM TIA SOLID WASTE MANAGEMENT CONSULTANTS FOR \$2800.00 FOR PREPARING 1991-92 RECYCLING GRANT APPLICATION.
2ND COMMISSIONER BOWDEN
MOTION CARRIED.

JACK CLARK, ARGUS SERVICES, WAS PRESENT AT THE MEETING TO DISCUSS RATE INCREASES FOR GARBAGE SERVICE OR ENFORCEMENT FOR MANDATORY GARBAGE SERVICE. MR. CLARK REPORTED HE HAD PICKED UP 229 NEW CUSTOMERS SINCE HE TOOK OVER THE GARBAGE COLLECTION. HOWEVER, HE HAS LOST 190 CUSTOMERS DUE TO NON-PAYMENT OF BILLS FOR THE SERVICE. HE NOW HAS 1421 CUSTOMERS IN CALHOUN COUNTY, HOWEVER, THERE ARE 2520 RESIDENCES IN CALHOUN COUNTY. HE STATED IT WAS SUPPOSED TO BE MANDATORY GARBAGE COLLECTION, HOWEVER, IT HAS NOT BEEN ENFORCED. HE STATED HE IS PAYING

A TIPPING FEE FOR ALL THE GARBAGE IN CALHOUN COUNTY EVEN THO HE IS ONLY COLLECTING FROM 1421 CUSTOMERS. MR. CLARK SAID HE CAN DO ONE OF FOLLOWING THINGS.

1. RATE INCREASE FOR EXISTING CUSTOMERS
2. WILL FORGET RATE INCREASE IF THE COUNTY WILL ENFORCE MANDATORY GARBAGE COLLECTION.

AFTER DISCUSSION, THE COUNTY ATTORNEY STATED HE NEEDED TIME TO REVIEW THE 1989 SOLID WASTE ORDINANCE AND ALSO AGREEMENT WITH ARGUS SERVICES. HE SAID HE WOULD HAVE A REPORT AT THE NEXT BOARD MEETING.

JULIAN WEBB, GRANTS SPECIALIST, WAS PRESENT AT THE MEETING TO DISCUSS THE CDBG AWARD AGREEMENT IN THE AMOUNT OF \$361,359.00.

AFTER DISCUSSION, MOTION BY COMMISSIONER BOWDEN TO ADOPT A POLICY IN ACCORDANCE WITH SECTION 519 OF PUBLIC LAW 101-40, THE 1990 HUD APPROPRIATIONS ACT PROHIBITING EXCESSIVE FORCE BY LAW ENFORCEMENT AGENCIES WITHIN ITS JURISDICTION AGAINST INDIVIDUALS ENGAGED IN NON VIOLENT CIVIL RIGHTS DEMONSTRATIONS. (SEE ATTACHED POLICY)

COMMISSIONER MELVIN ASKED COMMISSIONER BOWDEN TO CONTACT MS. BAILEY, WEATHERIZATION COORDINATOR AND MR. PARRISH, BUILDING INSPECTOR AND ASK THEM TO CHECK THE TRAILER OWNED BY ELLIS MARSHALL ON HIGHWAY 274 TO SEE IF MR. MARSHALL WOULD QUALIFY FOR WEATHERIZATION ASSISTANCE. COMMISSIONER BOWDEN SAID HE WOULD ADVISE MS. BAILEY TO CHECK THE TRAILER.

COMMISSIONER MELVIN STATED HE WANTED THE FOLLOWING INCORPORATED INTO THE COMPREHENSIVE PLAN: GASOLINE ENGINES WILL NOT BE USED ON MOSSEY POND OR MULE HEAD POND AND SHALL BE RESTRICTED TO ELECTRIC MOTORS OR PADDLEING.

COMMISSIONER WHITFIELD PRESENTED THE CITY OF ALTHA'S COMPREHENSIVE PLAN.

COMMISSIONER WHITFIELD RECOMMENDED THAT COMMISSIONER BOWDEN REVIEW THE CITY OF ALTHA'S PLAN SINCE THERE WAS A DEADLINE FOR SUBMISSION.


