THE MEETING WAS CALLED TO ORDER BY SHERIFF SMITH, AND FOLLOWED WITH PRAYER AND PLEDGE OF ALLEGIANCE TO THE FLAG LED BY COMMISSIONER WHITFIELD.

JIM PICKRON OF THE CITY COUNCIL OF BLOUNTSTOWN ADDRESSED THE BOARD CONCERNING A PROPOSAL REGARDING CHARLIE JOHNS STREET AND RIVER STREET.

CLERK WISE REPORTED \$50,000.00 FOR MAGNOLIA CHURCH ROAD WOULD BE CARRIED FORWARD INTO FYE 1992. \$69,000.00 OF RESURFACING MONEY WOULD BE CARRIED FORWARD. CLERK WISE QUESTIONED THE BOARD IF THERE WERE ANY OBJECTIONS. NO OBJECTIONS WERE GIVEN TO THESE CARRY FORWARDS.

CLERK WISE PRESENTED A LETTER FROM THE BUDGETARY COMMITTEE (ELECTED OFFICIALS) REQUESTING THAT 6.5% OF GAS TAX FOR ADMINISTRATIVE FEES BE RETURNED TO THE GENERAL FUND, \$58,784.00 WOULD BE THE TOTAL ADMIN FEES RETURNED TO FUND THE COUNTY. \$54,500 WOULD BE REQUIRED TO BALANCE THE BUDGET.

DISCUSSION ENSUED REGARDING THIS PROPOSAL.

COMMISSIONER MELVIN QUESTIONED PULLING \$43,000.00 OUT OF COUNTY TRANSPORTATION I BUDGET. HE STATED THE NECESSITY OF PURCHASING A MOWER TO MOW THE SHOULDERS OF THE ROAD.

\$4,500.00 WAS APPROPRIATED FOR PARKS, \$12,500.00 FOR HEALTH DEPARTMENT. BALANCE OF ANY MONIES LEFT OVER TO BE APPLIED TO RECREATION.

CHAIRMAN WHITFIELD REQUESTED MOTIONS FROM BOARD TO ACCEPT RECOMMENDATIONS FROM ADVISORY BOARD. NO MOTION BEING ISSUED.
