THE MEETING WAS CALLED TO ORDER BY COMMISSIONER WHITFIELD FOR THE PURPOSE OF OPENING OF BIDS ON PAVING OF MAGNOLIA CHURCH ROAD.

COMMISSIONER MELVIN REPORTED ON CONTACT WITH BOB KING REGARDING SPECIFICATIONS ON MAGNOLIA CHURCH ROAD. HE REPORTED MR. KING'S RECOMMENDATION WAS FOR 20 FT WIDE, 1 1/2 INCH THICK, S-1 ASPHALT TYPE.

COMMISSIONER MELVIN RECOMMENDED HIRING BOB KING TO TAKE COMPACTION TESTING AT APPROPRIATE INTERVALS TO INSURE 2" THICKNESS OF ROAD AND TYPE #2 SAHM.

COMMISSIONER MELVIN REQUESTED THAT A 10 FOOT STRIP BE PLACED IN FRONT OF THE CHURCH TO ENSURE PROTECTION OF THE ROAD.


