DEPUTY VICKERY CALLED THE MEETING TO ORDER. COMMISSIONER WHITFIELD  
LED IN PRAYER AND PLEDGE OF ALLEGIANCE.

DON A/ "SONNY" O'BRYAN GAVE THE BCC AN UPDATE ON THE HAZARD MITIGATION  
FUNDING.

MR. O'BRYAN DISCUSSED THE MAGNOLIA DISASTER SERVICES MATTER OF NOT  
HAVING PAID LOCAL VENDORS FOR MATERIALS THEY ACQUIRED DURING THE FLOOD  
'94.

MARIAH HUTCHINS, ARPC, ADDRESSED THE BOARD REGARDING THE HAZARD  
MITIGATION PLAN. MS. HUTCHINS EXPLAINED HER ACTIONS IN PUTTING THE  
PLAN TOGETHER AND HAS REQUESTED BOARD APPROVAL FOR HER TO COMPLETE THE  
GRANT APPLICATION TO BE SUBMITTED NO LATER THAN MAY 5, 1995.

MOTION MADE BY COMMISSIONER BOWDEN TO SUBMIT THE HAZARD MITIGATION  
PLAN AND THE 404 GRANT APPLICATION TO DCA, SECONDED BY COMMISSIONER  
WHITFIELD. MOTION CARRIED 5-0.

KELLI PEACOCK, REPRESENTING THE IDA BOARD, ADDRESSED THE BOARD  
REGARDING TWO VACANCIES ON THE IDA BOARD. ONE VACANCY BEING THAT OF  
"COACH" CARLTON SMITH WHO RECENTLY PASSED AWAY AND THAT OF CLIFFORD  
NEWSOME WHO HAS ASKED TO BE REPLACED.

THE IDA BOARD RECOMMENDS APPOINTING MANUEL GATLIN AND BILL TERRY TO  
THESE VACANCIES.

COMMISSIONER WHITFIELD MADE THE MOTION TO APPOINT MANUEL GATLIN AND  
BILL TERRY TO SERVE ON THE INDUSTRIAL DEVELOPMENT (IDA) BOARD,  
SECONDED BY COMMISSIONER GRANT. MOTION CARRIED 5-0.

COUNTY ATTORNEY MATTHEW FUQUA GAVE THE BCC AN UPDATE ON BILLY JOE  
TIPTON'S WORKER'S COMP STATUS. THERE IS NO LIGHT DUTY POSITIONS  
AVAILABLE TO BE OFFERED SO THE ATTORNEY RECOMMENDS THAT MR. TIPTON  
EITHER RETIRE OR BE TERMINATED.

COMMISSIONER WHITFIELD MADE THE MOTION TO ADOPT A PROCLAMATION IN HONOR OF THE 30TH ANNIVERSARY OF PROJECT HEAD START PROCLAIMING MAY 18, 1995 HEAD START DAY IN CALHOUN COUNTY, FLORIDA. COMMISSIONER BOWDEN SECONDED AND THE MOTION CARRIED 5-0.

MINUTES OF THE MARCH 21, 1995 REGULAR MEETING AND THE APRIL 4, 1995 REGULAR MEETING WERE APPROVED.

DISCUSSION WAS HELD CONCERNING THE COUNTY MEDICAID BILLINGS. THE BOARD WILL PAY QUARTERLY PAYMENTS OF \$15,000 BEGINNING OCTOBER 1, 1995 ON THE ARREARAGE AND KEEP CURRENT WITH ALL FUTURE BILLINGS - WITH EXCEPTION TO AN EXTRAORDINARY EXCESSIVE AMOUNT FOR ONE MONTH - THEN THE BOARD WILL NOTIFY AGENCY FOR HEALTH CARE ADMINISTRATION OF THE PROBLEM AND ARRANGEMENTS WILL BE MADE TO PAY WHAT CAN BE PAID AND TO PICK UP THE BALANCE ON A MONTH WHEN THE AMOUNT IS LOW.

MOTION MADE BY COMMISSIONER WHITFIELD TO ENTER INTO AN AGREEMENT WITH THE AGENCY FOR HEALTH CARE ADMINISTRATION TO PAY QUARTERLY PAYMENTS ON THE ARREARAGE BEGINNING OCTOBER 1, 1995 AND TO KEEP CURRENT ON ALL FUTURE BILLINGS. COMMISSIONER GRANT SECONDED THE MOTION. MOTION CARRIED 5-0.

VOUCHERS FOR WARRANT #9515 WERE APPROVED FOR PAYMENT.

THERE BEING NO FURTHER BUSINESS, THE BOARD DID ADJOURN.
